STC Graduation Requirements

- DegreeWorks
- Associate's Degrees require 60+ Hours
- STC Graduation May 11-12, 2017

Uniform Admissions Policy

- Must successfully complete the Foundation Plus Endorsement OR
- Meet the ACT College Readiness Benchmarks (English=18, Reading=21, Mathematics=22, Science=24) OR
- Earn at least a SAT assessment score of 1500 out of 2400 or the equivalent.

Top 10% Rule

- The top 10% law requires that *public* universities in Texas give automatic admission to high school students in one of their first two years after their graduation if they are in the top 10 percent of their graduating class.
- HB 1843 exempts UT from the top 10% law. UT caps the number of students automatically admitted at **Top 7%** for **entering freshmen fall 2018**.

Apply Texas Essays

• Topic A: REQUIRED (saved)

What was the environment in which you were raised? Describe your family, home, neighborhood, or community, and explain how it has shaped you as a person.

• Topic B: REQUIRED (saved)

Most students have an identity, an interest, or a talent that defines them in an essential way. Tell us about yourself.

Topic C: optional (unsaved)

You've got a ticket in your hand -- Where will you go? What will you do? What will happen when you get there?

Senate Bill 1528

Legislative Bill that allows students who are non-residents to be classified as Texas Residents for College Admissions and Financial Aid (State Funds) purposes only and if the student:

- Has resided in Texas three (3) consecutive years leading up to graduation,
- Will reside in Texas for 12 consecutive months prior to enrollment,
- Will graduate from a Public Texas High School or receive their GED
- And provides a notarized statement that the student meets the above criteria and intends to apply for Permanent Residency at the earliest opportunity.

Tests what student has learned throughout high school	Tests student's logical thinking skills "What you do with what you have learned"
Tests areas of: Math, Reading, English, Science and Writing (optional)	Tests areas of: Critical Reading, Math, and Writing
Score range: 1 – 36 on subjects Writing score range: 2-12	Score range: 200-800 on subjects Writing score range: 2-8

Bacterial Meningitis

- State legislature requires all students enrolling in a college/university to show evidence of an initial bacterial meningitis vaccine or a booster dose during the five years preceding, and at least 10 days prior to, the first day of college classes.
- Check with family doctor, local clinics, and pharmacies for prices.

FAFSA Free Application For Federal Student Aid

- Free online government application can be used for universities and colleges nation wide
- Apply online at <u>www.fafsa.ed.gov</u>
- Used to apply for Grants, Work Study and Loans
- Funds are awarded to HS graduates upon registration of courses
- FAFSA application opens up <u>October 1st</u>
- 2016 Tax Returns may be used to apply
- Requires FSA ID for student and parent

What is an FSA ID?

- The FSA replaced the Federal Student Aid Pin in May 2015
- Username and password used to visit certain U.S. Department of Education websites
- <u>Confirms your identity</u> and is used as an electronic signature for the FAFSA
- Both parent and student must have an FSA ID to complete and sign the FAFSA
- Visit <u>www.fafsa.ed.gov</u> and click on the FSA ID link to create your FSA



Estimated Family Contribution

• **EFC** Estimated Family Contribution is calculated by all the information provided on the FAFSA.



Cost of attendance	\$14,000
-EFC	3,000
Financial Need	\$11,000

Important financial aid tips to remember:

- Prior-prior year tax returns can now be used to complete the FAFSA
- Use the IRS Data Retrieval System for faster processing.
- Make sure all information provided on the FAFSA is current and accurate; mistakes can cause major delays in processing
- Priority Deadline is MARCH 1: all verification documents must be submitted by this date!

After you apply...

- Review your <u>S</u>tudent <u>A</u>id <u>R</u>eport SAR
- Submit Verification Worksheets, if requested by university. Follow up ONE week later.
- If no Verification Worksheet is required, an award letter will be sent to you. Review this letter and follow up with your university to accept or deny award.
